

Administrative fees charged by the University of St.Gallen

issued by the Board of Governors of the University of St.Gallen on 29 April 2013 pursuant to Art. 3 of the Fee Regulations of the University of St.Gallen (Consolidated Statute Book of the Canton of St.Gallen, No. 217.43)¹.

A. Non-chargeable services

The usual degree-course-related services are basically included in the tuition fees, and no separate fees are charged. Such services are, in particular²:

- standard notifications, such as notifications of grades;
- regular confirmations/permits;
- changes of address;
- issuance of a student ID per semester;
- crediting;
- regular enrolments;
- general information;

- confirmations of matriculation without signature;
- one confirmation of exmatriculation;
- confirmation of internship (without *Convention de Stage*);
- utilisation of group rooms;
- welcoming (enrolment) service.

B. Chargeable services

Separate fees are charged for individual and special services that are not covered by the tuition fees:
